 - 9.2 PCSO Vickie Hedges attended the meeting and talked briefly about local crime and the continued efforts of the police to deter rural thefts including patrolling local areas at night.
 - 9.3 Future funds may be available through the AONB to help collate information and produce a parish map which could be put on to the website. Dorset AONB is also hoping to use fixed point photography to show how the local landscape is changing, for which they are looking for local volunteers with a keen interest in photography. *Parish Clerk to include in LVN article*
